

International Service of Process Quash: Our Expertise

Our Quashing Expertise service is guarantee to quash only European Economical Community countries' service of process where an International defendant was served under certain circumstances and either by one of the three channels for International service proposed by Article 10 of the Hague Convention of 1965 or Service of Process by the main channel itself (Formal service). We reserve ourselves the right to accept or refuse cases after exam.

The International arena is the field of excellence for abuses, scams.... and "fraud to international law"; The Hague Convention has been tremendously abused by Translators, Interpreters, Detectives, Agents and Private Investigators worldwide and even by some North American Associations of Process Servers: Indeed, service of process by article 10 of the Hague Convention or the main Channel are reliable, if and only if completed properly: Either by legal professionals who respect "Foreign and Local" rules of Procedure and in due form.

Article 10 of the Convention clearly distinguishes in subsection b and c between two kinds of Private International Process Servers: Judicial Officers and other Competent persons (Who is considered competent by internal laws of Procedure? The answer varies depending on the Jurisdictions, but in mainland Europe: Attorneys at Law). Service complete without the use of these professionals can be quashed. Also important is to consider the Form of service, Place of service, Service hours...

Central Authority International Service can be also Quashed based on violations of local Law of Procedure, Constitutional rights of a defendant, by violations of Civil Laws.... Improper service form or by defective service (Translations....), Missing documents....

On the other hand, please note that there is an enormous legal difference in the service of process theory and practice between "Common law legal Systems" and "Roman Napoleonic Civil Codified law Systems" (All of Europe except UK and Ireland). In Common law Countries, almost anyone can serve legal documents without being a "Legal Professional" such as P.I.s, Translators, Lay persons In mainland Europe, to serve documents, you must be a legal professional, either registered with the department of Justice as a "Judicial Officer" (Offering Professional guarantees), or by an Attorney at Law controlled by the Government and member of a Professional Bar Association. There is no way that a limited liability Corporation can be a Process Server.

UK Private detectives and Investigators Nor any mainland European Private Detective or Investigator can not serve Process in mainland Europe without risking our **guaranteed quash**, because? if internal laws of procedure establishes that only "Judicial Officers" and "Attorneys at law" (Solicitors and Barristers) can serve process in their jurisdictions or perform judicial acts then, Where do P.I.s, Translators and other lay persons get their Authorization to practice International Law by serving International documents in mainland Europe?

Our quash service is based on Civil Law, Laws of Procedure and Constitutional rights, "Lex fori exigencies according to the country's "lex celebrationis".

Let's exam Article 10 of the Hague Convention:

1. 10-a Service by mail
2. 10-b Bailiff, Process Server....
3. 10-c Qualified Professionals

1. 10-a **Service by mail**: Private or Public courier: Disadvantages;

- a. Affidavit of Service: These services do not issue an Affidavit but a Postal receipt that is not detailed enough nor Authenticated. The signature of the return receipt is not necessarily by defendant or a qualified representative, the signer, in general, can not be distinguish nor identified.

b. Contents: The contents of the documents delivered is not controlled, defendant does not acknowledges Service of Process, therefore is an unilateral act of “giving something”, jurisprudence has considered, in some cases, that this kind of service is mostly evidence of an existing address more than a real International Service of Process.

c. Server: The International Process Server is completely anonymous.

2. 10-b **Bailiff, Process Server, "Huissieur", "Procurador"....** only persons affiliated to one of the Governmental Associations that are members of the International associations of "Judicial officers" for Europe offer the necessary legal guarantees, this excludes translators, interpreters, Private Investigators, Detectives, Agents.... This excludes also Non European Attorneys acting in Europe. Indeed, most of these "Fake Process Servers" will disappear in the moment of verification or in front of a motion to quash.

3. 10-c "**Qualified Persons**", depends on the Jurisdiction and its internal laws of procedure in general refers to Legal Professionals, Attorneys at Law, Barristers or Solicitors, qualified to practice law under an Ethical Code of Conduct (Confidentiality, Fidelity...), professionals who offer guarantees of integrity and reliability.

Indeed, the criminal sanction for "fraud to International Law" in relation to International Process Service laws can result from;

- Illegal Practice of Law
- False representation
- Defamation
- False Private Document
- Abuse of Confidence
- Harassment
- ...

Contingency Quash: If a Private Detective, Translator or Investigator served documents in mainland Europe: We accept to issue our "Legal opinion expertise" to quash that service for an "on Contingency lawsuit" in North American courts and file a Criminal complaint for unfair competition and illegal practice of law in any European courts for free.
